

PRIVACY POLICY OF THE 'VRIJE WADLOPERS'

This Privacy Policy applies to all personal data processed by the Vrije Wadlopers related to its members or participants.

If you become a member of the Vrije Wadlopers, or are interested in a mudflat hiking trip of the Vrije Wadlopers, you give permission to process your personal data in line with this Privacy Policy. We advise you to read and keep this Privacy Policy for your own administration.

1. Responsible

Responsible for the processing of personal data is: Vrije Wadlopers, aanvraag@vrijewadlopers.nl, Chamber of Commerce number 01162455 - De Marne.

2. Which data are processed by the Vrije Wadlopers process and for what purpose?

2.1 In the context of the notification for a mudflat hiking trip, the following personal data are processed:

- a) first and last name
- b) address details
- c) telephone number, e-mail address, bank account number

For members (= guides) the birth date and gender are also processed.

2.2 The Vrije Wadlopers processes the personal data referred to in 2.1 for the following purposes:

- a) your name, address, telephone number and e-mail address will be used to contact you about the registration and any cancellation thereof, for the provision of your requested information or handling the information obtained from you,
- b) your name and e-mail address to your annual e-mail newsletter with the Vrije Wadlopers program for the coming year. Cancellation for these mailings is possible at any time through the unsubscribe link at the end of the mail.
- c) your name and bank account number is used to make payments for mudflat hiking trips or to settle other services purchased.

2.3 Your name and telephone number will be used no later than two years after the end of the agreement to inform you about the developments of the Vrije Wadlopers.

In addition, members will use the data for third-party certifications, announcements / minutes of the General Assembly, calling for guides on certain trips and for collecting membership fees.

3. Storage periods

The Vrije Wadlopers process and store your personal data for a maximum of two years after the last mudflat hiking trip.

For members we process and store your personal data for the duration of your membership up to a maximum of one year after the end of this membership. Subsequently, the personal data will be destroyed.

4. Security measures and processors

4.1 For the protection of your personal data, the Vrije Wadlopers have taken technical and organizational measures.

4.2 For the processing of the personal data, the Vrije Wadlopers make use of the services of third parties, so-called processors. We have a processing-agreement with the processor.

5. Right of inspection, removal and complaints

5.1 Through the administration of the Vrije Wadlopers you can submit a request to view, receive, change or delete your personal data. The Vrije Wadlopers will process your request and inform you about this within two weeks after receiving it.

5.2 If you wish to object to the (further) processing of your personal data as referred to in Article 2, you can also contact the administration.

5.3 If you have complaints about how the Vrije Wadlopers process your personal data or treat your requests, you can contact the data protection officer Bé Muurman.
